Not give out information such as my surname, address, telephone number, or parents' work address/telephone number.	
Never send a person my picture without first checking with my teacher or parent if at home.	
Compose e-mail, blog, wiki, and twitter etc. messages using only language I understand is acceptable in my school.	
Not respond to any messages that are unpleasant or that make me feel uncomfortable in any way. It is not my fault if I get a message like that.	
Notify the teacher if I receive anything unsuitable.

Be aware that my internet usage may be supervised at any time.
